

# Sandalwood Lake Party Guidelines

- \*Review the lake rules, which are posted at the waterfront and in the directory. Please no fishing in the roped swimming areas (hooks are a problem for bare swimming feet), and no glass bottles.
- \*One lifeguard is required for every 10 people in the water.
- \*Please be prepared to clean up the area **prior to the party**, including the bathhouse.
- \*The restroom combination (both male and female) - press 5, then 4.
- \*Pick up all trash and clean up after the party. **There are 3 large trash cans that need to be emptied into the large BFI containers and the trash bags need to be replaced.** The trash cans in the bathhouse also need to be emptied and trash bags replaced. **Please bring 3 garden size trash bags with you for your party (may need more depending on size of your party).**
- \*Clean up bathhouse, turn off all lights and fans and make sure bathhouse doors are locked.
- \*Deposit checks will be destroyed unless otherwise notified.

1. I, \_\_\_\_\_, accept responsibility for the safety and behavior of my guests during private function for which above request is made. I have received, read and agree to enforce all Sandalwood Civic Club, Inc. ("Party" and "Lake") rules for the swimming area, bathhouse, adjacent areas and associated equipment. These areas can be dangerous and I will therefore exercise due caution to prevent accidents involving my guests and myself, and will accept all responsibility and assume all risk, whether known or unknown. Furthermore, I agree that the Club, it's Directors/Officers and residents are not responsible for the safety or conduct of my guests and myself during said function and therefore hereby release and forever discharge the Club, it's Directors/Officers and residents from any and all liability whether known or unknown. This release shall survive the termination of this agreement.

2. I will maintain Patti Lynn Lake, bathhouse, adjacent areas, and associated equipment, in acceptable condition during the function. Upon termination of function, the said areas will be immediately returned to the same condition as existed prior to the function. All trash is to be placed in plastic garbage bags inside the trash cans provided on location. Particular attention will be paid the bathhouse restrooms, which will be cleaned, lights turned off and locked once function terminated. Failure to comply with the foregoing shall result in the forfeiture of said Security Deposit, without notice.

3. I hereby defend, indemnify and hold the Club, it's Directors/Officers and residents harmless from all liability whether known or unknown. This provision shall survive the termination of this agreement.

4. Swimming will be at your own risk.

5. The lake, bathhouse, adjacent areas and associated equipment is provided "AS IS", "WITH ALL FAULTS", whether latent or patent, without representation or warranty, expressed or implied. The undersigned has inspected the lake, bathhouse, adjacent areas and associated equipment and is satisfied with every aspect of the same.
